INVEST IN EDUCATION WAS CERTIFIED AS AN OFFICIAL STATEWIDE BALLOT MEASURE, WITH THE NAME PROPOSITION 208, IN AUGUST OF 2020. PROPOSITION 208, WHICH ULTIMATELY PASSED IN NOVEMBER OF 2020, WILL RAISE \$940M PER YEAR TO HELP ADDRESS THE STATE'S TEACHER SHORTAGE CRISIS, HIRE ADDITIONAL COUNSELORS, NURSES, SOCIAL WORKERS, AND AIDES, AND DOUBLE THE STATE'S INVESTMENT IN CAREER AND TECHNICAL EDUCATION COURSES. STAND'S CONTRIBUTIONS INCLUDED CO-LEADING THE INVEST IN EDUCATION'S COALITION'S SIGNATURE GATHERING AND TARGETED VOTER CONTACT. STAND ARIZONA WAS ALSO SUCCESSFUL IN SUPPORTING THE STATEWIDE ADOPTION AND EARLY IMPLEMENTATION OF IMPROVED, EVIDENCE-BASED ELL INSTRUCTION THAT IS REQUIRED IN THE 20-21 SCHOOL YEAR.

STAND COLORADO WORKED WITH KEY STAKEHOLDERS TO GET A MEASURE ON THE BALLOT THAT WOULD INCREASE QUALITY PRE-K EDUCATION BY \$250M IN COLORADO FOR THE GREATEST NUMBER OF LOW- AND MODERATE-INCOME CHILDREN. THIS EFFORT CULMINATED IN THE CREATION OF PROPOSITION EE, A STATESIDE BALLOT MEASURE TO INCREASE FUNDING FOR PUBLIC SCHOOL AND UNIVERSAL FREE PRE-SCHOOL FOR ALL FOUR-YEAR OLDS.
