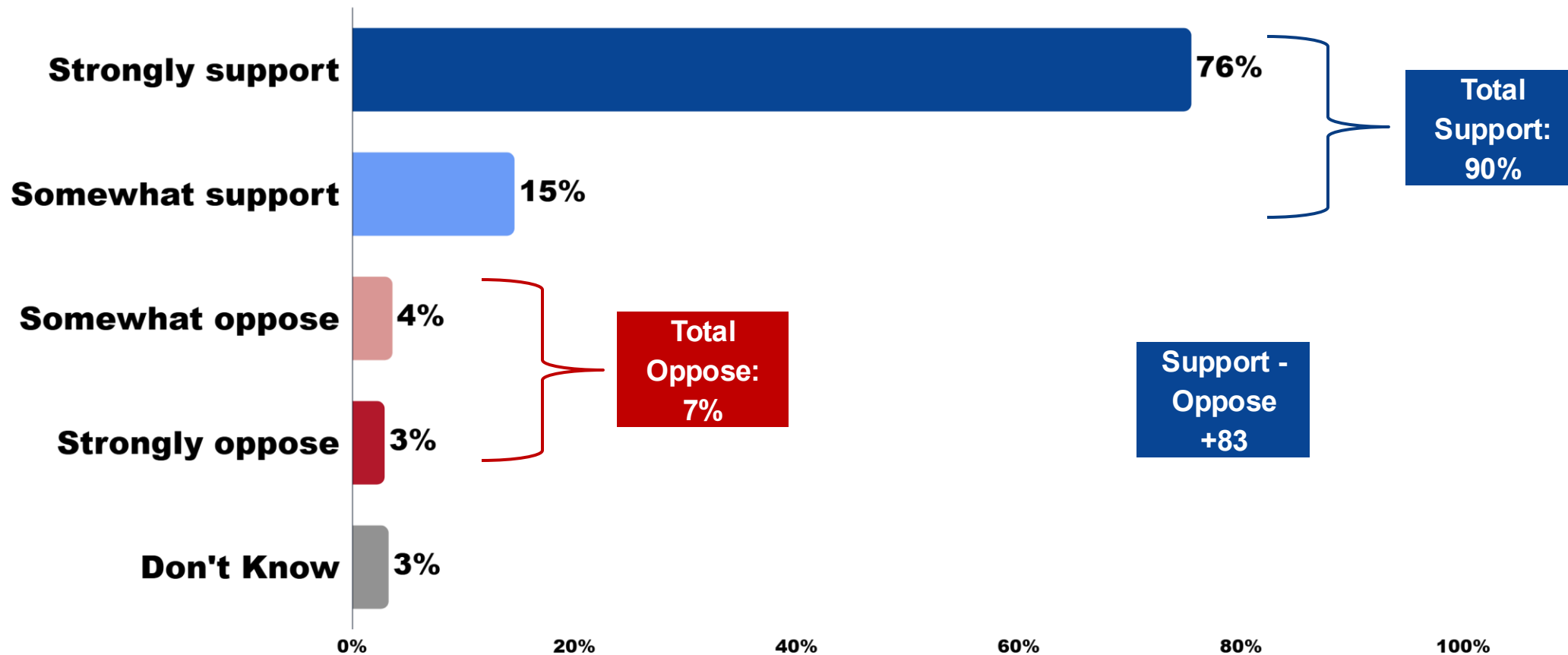

Methodology

- **Arizona statewide survey among 800 likely 2026 general election voters.**
- **The margin of error is +/- 3.47% for the full 800 sample.**
- **Live phone interviews conducted in English and Spanish by professional callers dialing both landlines and cell phones as well as interviewing a portion of respondents online through e-mails and text messages from the voter file.**
- **Fielded November 15-23, 2025.**

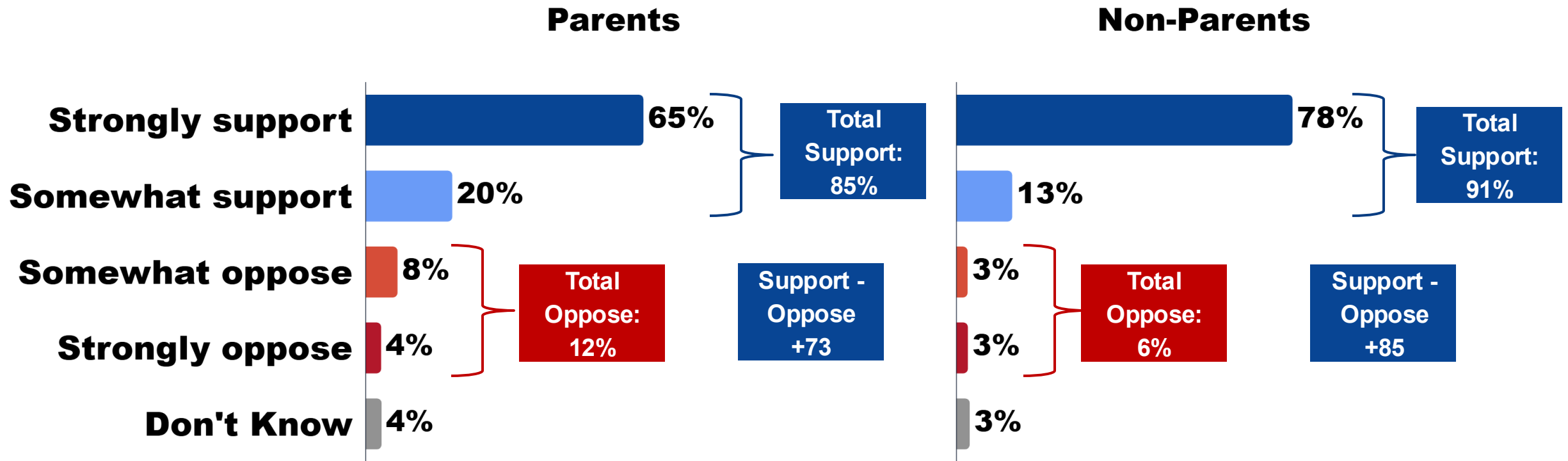
Nine in Ten Voters Support Arizona's Law that Limits Cell Phone Use by Students in Schools

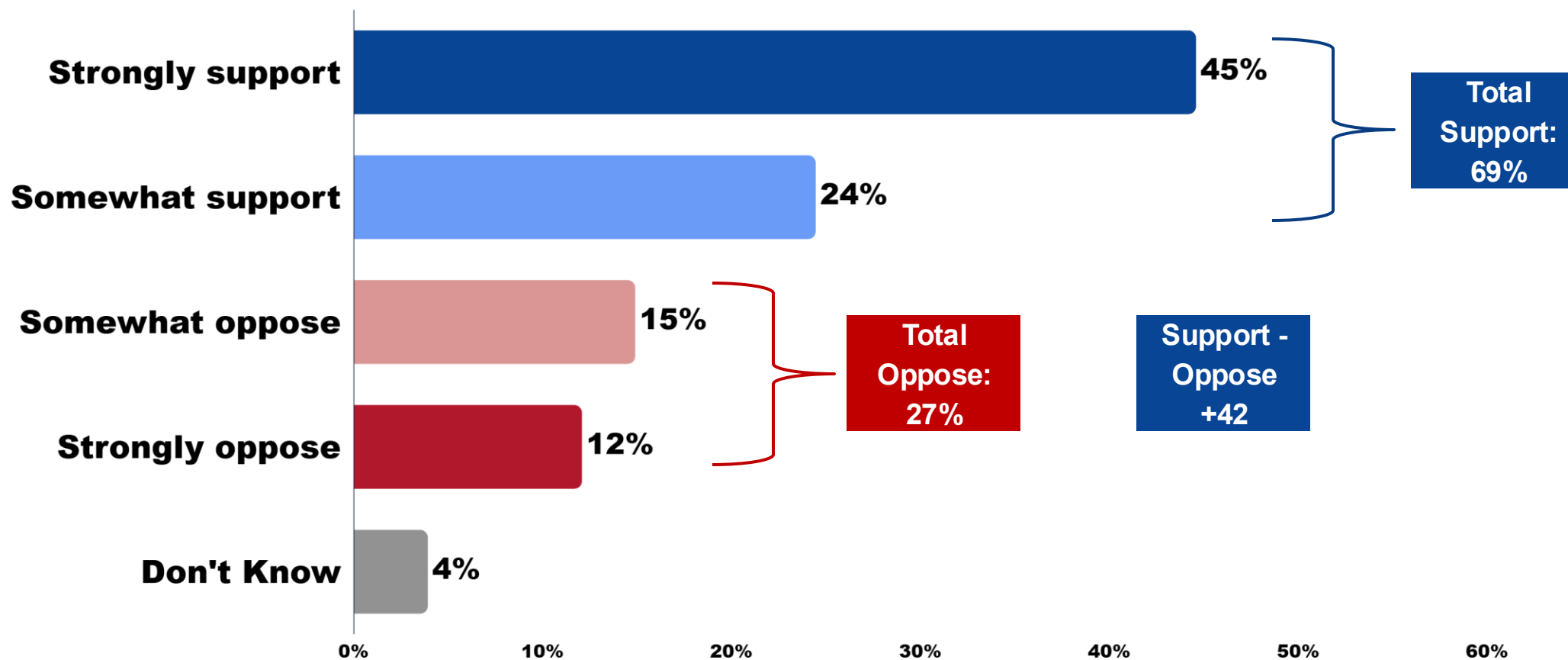
Support for School Cellphone Limitations by Parental Status

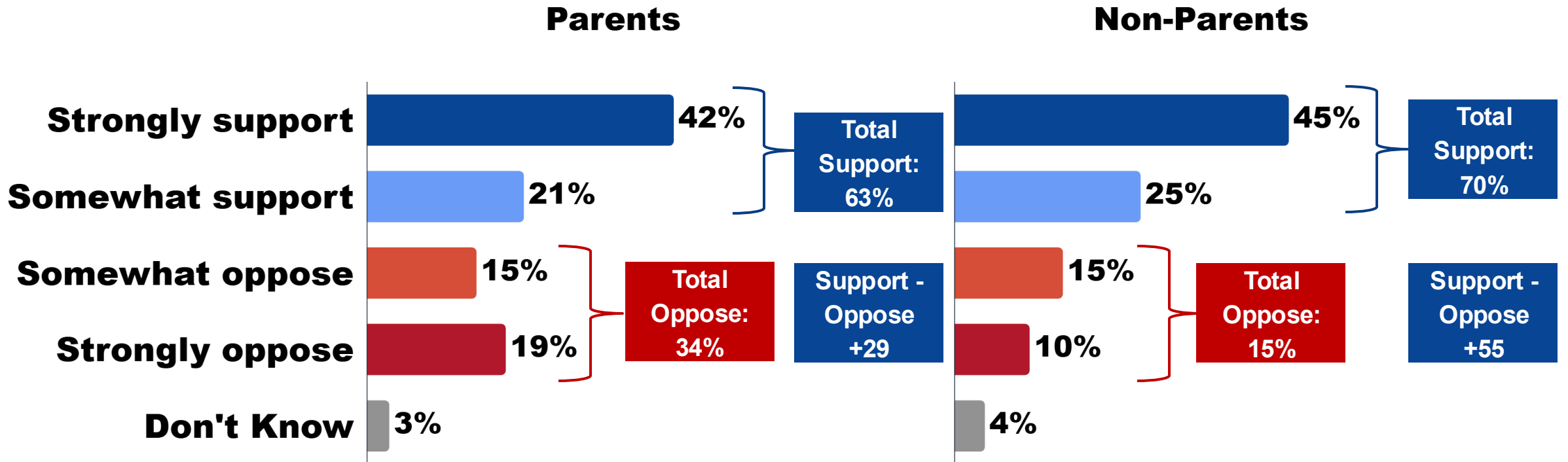
A Strong Majority of Voters Support Having All School Grades Go Phone Free for the Entire Day

Would you strongly support, somewhat support, somewhat oppose or strongly oppose having all school grades, including high school, go phone free for the entire day, including during lunch and recess?



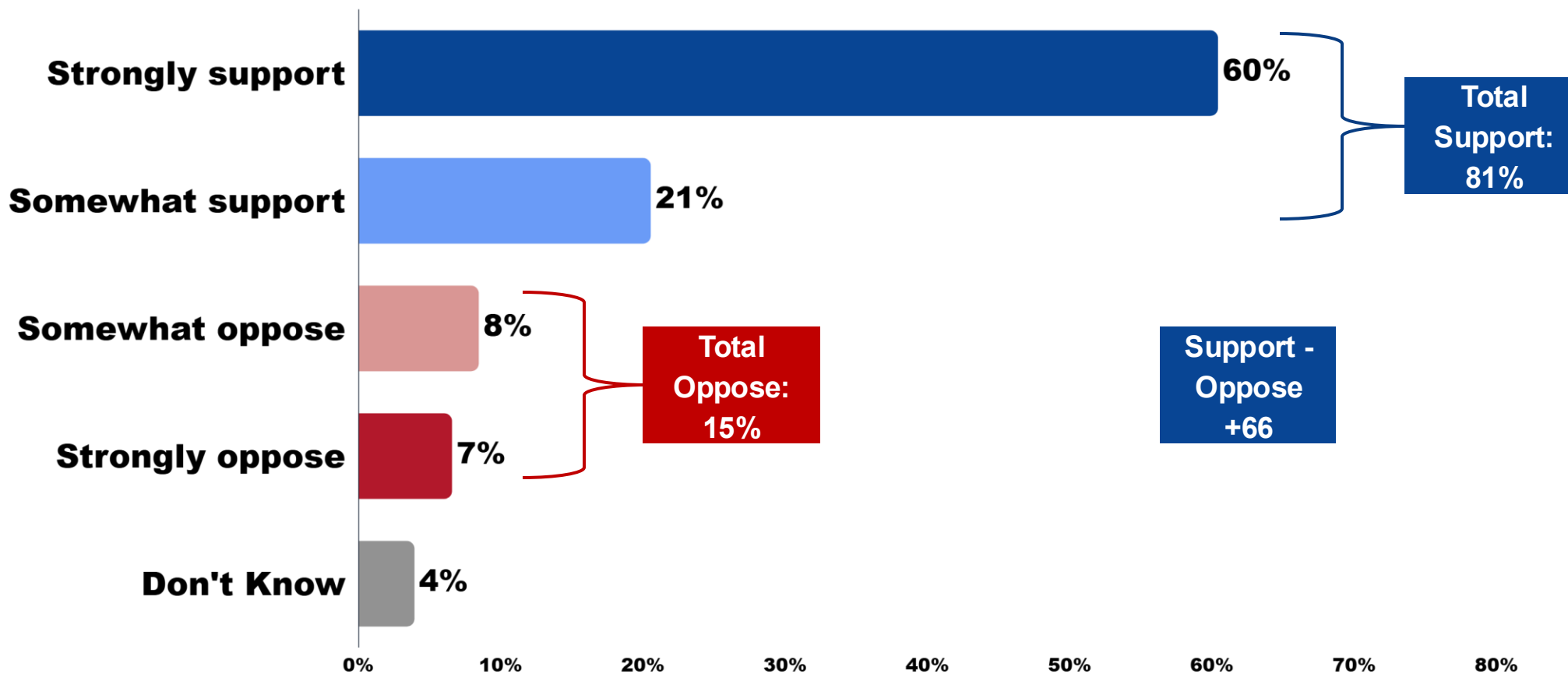
Support for School Phone Ban by Parental Status

Would you strongly support, somewhat support, somewhat oppose or strongly oppose having all school grades, including high school, go phone free for the entire day, including during lunch and recess?



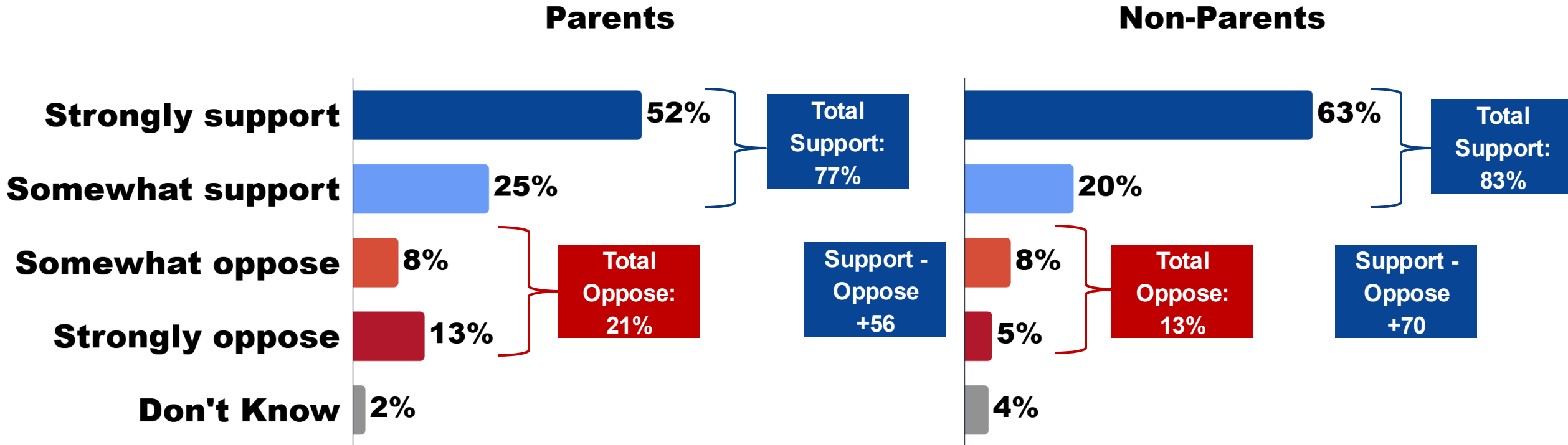
Voters' Support for Schools Prohibiting Smart Phones for the Entire Day Increases After Exposure to Research Findings

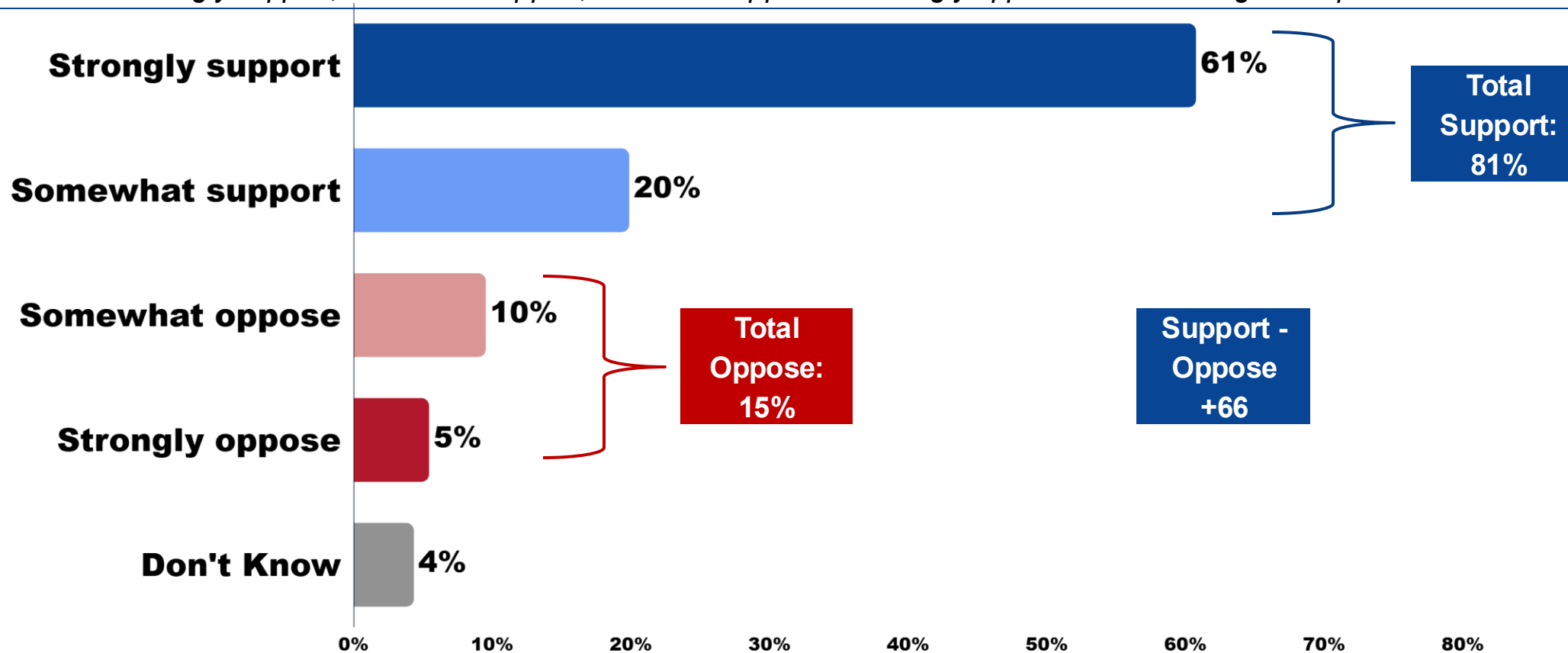

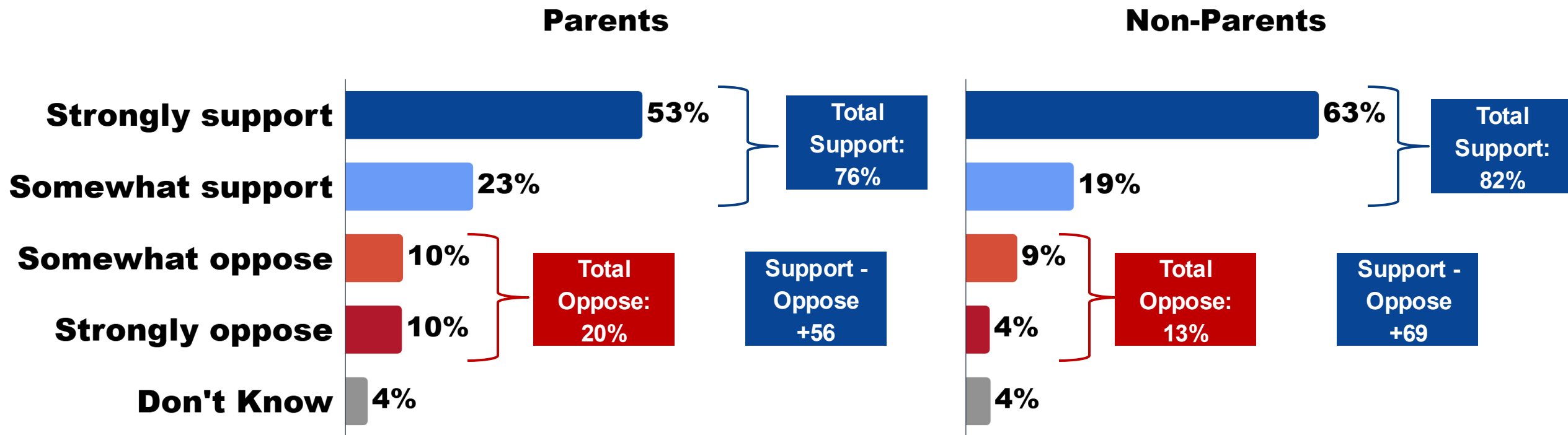
Voters Maintain Strength in Support for Phone-Free Schools After Hearing More Information
